C.R. SMITH MUSEUM RULES, GUIDELINES & INFORMATION

➤ Museum Rules of Conduct

1. The rights of all museum patrons must be respected. Group members are to 1). Use indoor voices, 2). Must not run or climb 3). Must not act in a boisterous manner, 4). Must not abuse exhibits 5). Must not play in the revolving doors 6). Must not block isles, entries or exits 7). Be courteous to other patrons
2. Group leaders are responsible for the conduct of their group at all times, including in the Gift Shop, Theatre and aboard the DC-3 airplane. Due to our campus security policies, we reserve the right to ask unruly visitors/rule violators to leave the premises.

➤ Confirmation, Payment, Activities, Educational Workshops and Adult to Child Ratios

 - a. Please note: We are unable to officially reserve your spot until the completed reservation form is received.

➤ Group Staging, Entry and Check-in Procedures

1. Groups are to stage outside the Museum near the benches in front of the DC-3 Hangar until all group members are present and ready to enter the Museum
 - a. In cases of inclement weather, groups may stage inside the museum near the Platinum Wall. Group leaders must ensure all individuals follow conduct rules as stated above. Please see Museum staff for assistance.
2. The group leader is to check-in their group at the Gift Shop upon arrival.
3. Please note, Museum activities/programs are subject to change without notice.

➤ Dining

1. The museum is on the American Airlines corporate campus. Because of this, absolutely no picnicking is allowed on or around the museum grounds. There are no dining facilities at the museum, nor is food or beverage allowed inside the museum. Please plan ahead for lunches.
